## Booking and Consent form (continued)

We plan occasional trips out of Loveders Nursery School/Freezone Club as part of our curriculum delivery. We require your consent to take your child on such trips. We will advise you in advance of each trip so that you can have the opportunity to discuss any specific needs for that trip and to enable you to provide the necessary clothing and other possessions that your child may need for the trip.

Under the statutory requirements of the Early Years Foundation Stage, we are also required to obtain parental permission for emergency medical treatment for all children attending the school/clubs. We will always endeavour to contact you to advise you that such treatment is required.

The school/club takes photos of the children in all aspects of nursery/club life. Some of these are displayed for parents to see. Others are put in the book corner for the children to look at. We also use some for record keeping to show evidence of activities for OFSTED inspections, for our quality assurance work and for the children's Learning Journals, to assist staff under training and for promotional purposes. We will be using Baby's Days software to record selected milestones and activities for your child. Evidence of these will then be sent to you electronically on a weekly basis. Your child may be in a photo that is sent to another parent.
